## COLLABORATION AND LEADERSHIP: HIGHLIGHTS

### Academic

- designed and founded a new Center for International and Area Studies at Northwestern University (WCCIAS). This involved support of the Dean of Arts and Sciences and the University Provost to build an institution that supports faculty research, student engagement, and public outreach on global affairs. Three years from inception, it now includes a dozen faculty research clusters, three undergraduate majors/minors, language instruction, visiting faculty and practitioners, and a platform for future growth to serve the entire university. It also consolidates administrative support for event planning, visas and visiting appointments, and faculty support.
- overhauled the International Studies undergraduate program, one of the largest majors in the College of Arts and Sciences, to reflect contemporary issues in global affairs and enhance the student experience. This resulted in new courses, new thematic clusters, and new language requirements for students and new governance and oversight for faculty.
- launched weekly global-affairs podcast to highlight Northwestern scholars and scholarship in an informal and engaging format. The series publicizes the work going on in the university and amplifies the profile of individual scholars to a broad audience.
- with Dévora Grinspan, developing a series to host Consuls-General at Northwestern in a multi-year program to integrate global diplomatic practice into campus life in Evanston. In 2021 and 2022 we piloted with program with the Consuls-General of Germany and Latvia and the Representative of Taiwan to the United States.
- developed an annual mentoring academic workshop for young scholars in international law and politics to help diversify the pipeline for academic recruitment. Worked closely with Notre Dame Law School, the American Bar Foundation, and the University of Wisconsin to host events, attract promising scholars, and provide mentoring on worksin-progress. Over four years, these events hosted about 60 young scholars.

### Institutional

- built the back-office systems for the WCCIAS for scalable administrative workflow as the Center grows from start-up to fully functioning academic center. With Senior Associate Director Bianca Jimenez, we designed administrative structures that make it easy for units in the Center to access support for their needs of all kinds. Given the diverse units in the Center, we sought to make staff support systems that are modular and scalable, to encompass today's needs and also expansion in the future. Staffing the Center has increased three-fold in the past two years while activities have increased by a factor of ten.
- with Mary Finn, led the Curricular Policies Committee to revise the College policies on on-line instruction. Campus-wide consultation led to a comprehensive policy framework that attends to student experience, classroom facilities, diverse faculty preferences, and intellectual property, among other issues.
- led the International Organization section of the International Studies Association, with oversight on finances, membership, committees, and prizes, with an eye on contributing to the Association's goal of building pathways for scholars from the Global South.

• as President of the Board, led The Musical Offering through a transition from artist-led music cooperative to a sustainable non-profit. This involved clarifying the operating procedures, staff roles, and relations between Board and artists. The organization went from a position of uncertainty to a solid foundation across Board, staff, and finances.
